APUC Supplier and Framework agreement Management website

Purpose

The website has been created to enable institutions to easily register their adoption of the APUC Frameworks and provide a feedback tool. Informing commodity managers about the Framework in general or raising issues/praise for specific suppliers.

Details of all the current Framework agreements and the contact details of the managers are available on the website to allow institutions to easily access the agreements.

User Instructions

- 1. You will have been supplied with a personal Username and Password to access the website. If not known, contact <u>helpdesk@apuc-scot.ac.uk</u> to obtain.
- 2. If you require additional people in your organisation to have access please provide details to <u>helpdesk@apuc-scot.ac.uk</u> to provide them with their own log in details.
- 3. Access is via your internet browser which should preferably be IE8 or Firefox.
- 4. Enter the web address <u>http://www.contractmanage.apuc-scot.ac.uk</u> in the browser window.
- 5. You may wish to add to your favourites to save time in future.



6. Enter your username and password provided and click "Log In"

7. You will arrive at the Home screen.



8. Click on the 'Framework agreements' link on blue taskbar at top. This will take you to the available frameworks screen.

- 9. Once in the framework list screen you will see list of available frameworks. Multiple pages of frameworks are available and they can be navigated by using the navigation buttons at bottom of screen.
- 10. By hovering over the "Show Uptake Codes Help" a pop up screen gives guidance to the coding to be used to categorise your usage of the frameworks.

This facility can be accessed from various screens within the website by clicking wherever you see comment or comments on the screen. The filter narrows down the comments to supplier if required. Showing all suppliers lets you see all comments made by other users of the commodity framework.
